IV. Pending Items for Review

- a. Cook County Medical Examiner
 - Dr. Gates provided an update about his findings of the Medical Examiner's protocol for cases of suspected abuse or neglect with older adults. At this time there is no protocol in place.
 - Dr. Gates recommended that the Medical Examiner's protocol for cases of suspected abuse or neglect with older adults should reflect the protocol in place for cases of suspected cases of child abuse or neglect.
- b. Illinois Hospital Association (IHA)
 - Dr. Joshi has made follow up with IHA and will develop a survey to poll their members later this month.
- c. Required Training Topics for In-home Service Workers
 - Team recommended mandatory training for all in-home service providers to recognize potential signs of abuse and neglect. No changes at this time.

 - Purpose is to allow teams across the state to communicate about general themes within cases.
 - Holly Z. discussed posting a list of all the team Chairs and co-Chairs and the dates in which they were elected. This request was made by the State Advisory Council.
