  - i. It appears as though some hospitals do not take photos while others have policies that do not allow them to share their photos with Adult Protective Services investigators or law enforcement
  - ii. There was a question on if there was guidance from the Centers for Medicare and Medicaid Services or the Joint Commission on allowing photos to be taken to document abuse. Roz Lennon will check on the regulations.
  - iii. The team may push this issue forward with the Illinois Hospital Association and address a uniformed policy on taking photographs in the hospital.
