



## Illinois Dual Eligible Special Needs Plans Comparison (D-SNP) Chart

**PLEASE NOTE:** Information in this document is based on the Member Handbook for each Illinois D-SNP

**All D-SNPs will cover:** Medicare Part A services, Medicare Part B services, Medicare Part D (prescription drug coverage), Illinois Medicaid services, and Long-Term Services and Supports (LTSS)

**All D-SNPs are Medicare Advantage Health Maintenance Organizations (HMOs)** and will require enrollees to choose a primary care provider. Enrollees must remain in network to receive coverage.

**All D-SNPs have a Continuity of Care period** where enrollees can see out-of-network providers if they are currently receiving treatment. Enrollees will receive an 180-day period if they are newly enrolled into a D-SNP and a 90-day period if they are switching to a different D-SNP.

## Supplemental Benefits

Medicare Advantage Supplemental Benefits **covered by ALL D-SNPs**: Vision\*, hearing\*, dental\*, fitness benefits, over the counter drugs\*, meals for short duration, annual physical exam, telehealth, worldwide emergency.

Medicare Advantage Supplemental benefits that are **NOT** covered by all plans: Massage therapy, counseling services, support for caregivers of enrollees, transportation to any health-related location, post discharge in home medication reconciliation, pre-admission prevention, weight management programs, adult day services, and home-based palliative care.

### Supplemental Benefits That Vary Across Plans

**Please note** that all supplemental benefits a plan covers may have restrictions placed upon them. Benefits with an asterisk indicate that it is a Medicaid covered service that D-SNP plans may provide benefits beyond Medicaid coverage requirements.
